The Ministry of the Environment and Climate Change has reviewed the following ground-borne vibration monitoring program for construction pile-driving submitted in accordance with Condition H2 of Renewable Energy Approval (REA) No. 5272-A9FHRL, issued on June 29, 2016:

- *Phase 2: Production Pile Vibration Monitoring Program, North Kent Wind 1 Project, Chatham-Kent, Ontario, dated June 7, revised June 9, 2017, and prepared by Storer J. Boone, Ph.D., P.Eng., Golder Associates Ltd.*

Pursuant to Condition H3 of REA No. 5272-A9FHRL, please accept this letter as written approval of the ground-borne vibration monitoring program for construction pile-driving. North Kent Wind 1 LP is requested to ensure that the above-noted document and this letter are made available on the project website.

While issuance of this letter constitutes approval for the ground-borne vibration monitoring program for construction pile-driving, in accordance with the above-noted document North Kent Wind 1 LP must not proceed with pile-driving at turbines and other infrastructure outside of the cluster depicted in the above-mentioned document until North Kent Wind 1 LP provides the Director with a document which identifies the remaining turbine clusters and the two domestic water wells that will be monitored within each cluster, and the Director confirms in writing that the submitted document is acceptable.

Please be reminded that in accordance with the above-noted document and the requirements of Section H of the REA, North Kent Wind 1 LP shall not commence operation of the project (i.e. blade rotation) until a ground-borne vibration monitoring program for project operations is submitted to and approved by the Director.
